One of the functions of the Board of Examiners is to assess applicants, or have applicants assessed, for certificates of competency. The written law examination tests an applicant's knowledge of relevant Queensland legislation (*Coal Mining Safety and Health Act 1999* or *Mining and Quarrying Safety and Health Act 1999* and corresponding regulations).

Written examinations are held at the listed locations around Queensland once a month. Examinations at other offices (i.e. Townsville, Mount Isa) are organised according to demand and staff availability.

For areas outside the ones listed, approved candidates may organise their own examination venue at a courthouse, library, school or similar government premises. The *consent, information and rules for external supervisors and candidates* information sheet can be accessed from website:

Candidates who submit an application must be ready to sit their examination once the application has been assessed and permission granted. Do not lodge your application until you are ready to sit the examination. Provision is made on the application forms for a preferred session to be nominated. If the application is approved, a candidate will be booked into the requested session if there are places available.

**Examination bookings must be received at least one week prior to the session date.**

Bookings can be made by phone, in writing or email. The maximum number of seats in some venues are strictly limited and will be allocated in order they are received. Confirmation will be provided in writing (via email). Venue details will be communicated at least one week prior to the session.

If are unable to attend a session, please advise the Secretariat as soon as possible.

On presenting for written examinations, all candidates must produce photo evidence of identity before being allowed to sit.

Examination papers are marked anonymously by a member of the Board of Examiners. When undertaking the examination, **do not** put your name anywhere on the paper. An identification number will be assigned to each application when submitted.

The marking process may take up to 8 weeks. Results of examinations will be communicated via email (where supplied) as soon as they are known.
