PROCESS

1. The applicant lodges an application and certified copies of proof of identity, certified copies of educational qualifications and shotfirer licence, if applicable, with the Secretary of the Board of Examiners.

Applications can be lodged via email.

Application for sites employing ten persons or less are not required.

2. Acknowledgement of receipt of the application will be emailed to the applicant.
3. The application and work history are forwarded to the Chief Inspector (Mines) or their delegate to confirm that the applicant meets the work history and qualification requirements to be granted a Site Senior Executive Notice Queensland (*Mining and Quarrying Safety and Health Act 1999*).
4. The application and work history and any comments if the applicant does not meet requirements are returned to the Secretary of the Board of Examiners.
5. If the application is approved, the Chair of the Board of Examiners or the Secretary on behalf of the Board of Examiners, signs the Notice and the Secretary issues the Notice. The Notice is forwarded to the applicant by registered post.
6. A record of the Notice is kept in the Register of Certificates of Competency and Notices with the date of issue and number recorded.

NOTE:

Applications that are not submitted on the current application form will be rejected.

Please take the time to download the current application form, read and address all the criteria.

Applicants who submit a second application that fails to meet all criteria as per the current application form, and any deficiencies advised, cannot submit a further application form for 12 months from the date of notification of decline.

The Board of Examiners (the Board) requires minimum practical experience and a minimum requirement of involvement in surface mining or quarrying operations aligned with the Site Senior Executive Notice Queensland issued under the *Mining and Quarrying Safety and Health Act 1999*. In order for the Board to be assured you have work experience that is relevant to fulfil the requirements of the Site Senior Executive's role, you are required to provide evidence verified by the Site Senior Executive who was appointed at the operation during the period against which you are claiming experience.

Holders of a Queensland First Class Mine Manager Certificate of Competency (Underground Metalliferous Mines) or Certified Practising Quarry Managers are **not** required to complete the work history document.

It is important that you demonstrate you have rounded experience covering a number of aspects of modern surface mining or quarrying practices. It is your responsibility to identify gaps in your work history against the requirements set out on the work history template

Providing job titles alone is not acceptable evidence. Additional sheets may be attached if required. Information provided will be cross-checked and the provision of any fraudulent information may result in the application being rejected.

Note: The summary sheets require signature/verification of the tasks. If you are unable to obtain the relevant signatures or written verification for the work from previous employers, you may submit a statutory declaration explaining the circumstances and verifying that the information provided in your work summary is true and correct.

For those applying for a surface mine or quarry employing more than 10 persons, experience should include:

- Five (5) years' experience in mining or quarrying
- of which at least two (2) years have been in a supervisory role

(or as determined by an Inspector of Mines given the nature and complexity of the operation)
